Angry local residents have joined forces with local Conservative Councillors to force a rethink over the badly thought out 'Greenway' scheme.

Residents want Tolworth Broadway to be improved but most question the scheme as currently proposed. The proposal includes the highly dangerous plan to remove the central safety barriers. It also proposes to have a central route called the "Greenway" (which is in reality just green paint on bricks) which forces cyclists and pedestrians to use the same roadway, a move regarded as highly dangerous to both.
